SEEPS TO BE ABLE TO GO TO COURT REGARDING CUSTODY AND VISITATION:

1. Must have a court case in Santa Barbara County Superior Court;
2. Must attend once the free 2-hour PEACE parenting class online:
3A. Must attend <u>voluntary</u> mediation through family Court Services and come to an agreement that is signed by a judge: *OR*38. Must prepare legal papers (Request for Order FL-300) to get a court-ordered mediation appointment and a court hearing date;

4. Attend court-ordered Family Court Services mediation, and if there's no signed agreement, then;

5. Go to court and have a judge make orders regarding custody and visitation
