I, the undersigned, do hereby agree:

- 1. I will appear at all times and places as ordered by the Court releasing me and as ordered by any court in before whom the charge is subsequently pending;
- 2. I will obey all laws and reasonable conditions imposed by the Court.
- 3. I will not depart this state without permission of the Court.
- 4. If I fail to appear as required and am apprehended outside the State of California, I waive extradition;
- 5. If I fail to appear or I violate any condition of this order or if there is a change of circumstances that increases the risk of failure to appear or additional facts are presented which are unknown at this time, any court or judge may revoke the order of release and return me to custody or require that I give bail or other assurance of my appearance.
- 6. I will allow the Probation Department to install a GPS device prior to my release from custody and I will comply with all GPS requirements, as directed.
- 7. I will avoid all contact with witnesses and/or victims: \_\_\_\_\_
