

Slide 6	STEPS TO BE ABLE TO GO TO COURT REGARDING CUSTODY AND VISITATION:	
	Must have a court case in Santa Barbara County Superior Court; Must attend once the free 2-hour PEACE parenting class online; A. Must attend <u>voluntary</u> mediation through Family Court Services and come to an agreement that is signed by a judge;	
	OR 38. Must prepare legal papers (Request for Order FL-300) to get a court-ordered mediation appointment and a court hearing date;	
	4. Attend court-ordered Family Court Services mediation, and if there's no signed agreement, then; 5. Go to court and have a judge make orders regarding custody and visitation
